Documents received after this deadline will not be accepted. The bidders are requested to submit the hardcopy of Bid Security and Original Catalogue/Brochures in the time of Bid Opening.

4. If the Bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited at Nepal Bank Limited, Bhugolpark Dharauti Account No. 00202000000003000001 of Treasury and Controller Office, Sundhara Kathmandu, mentioning the code No. 27-345-33 of this office and the receipt of the deposited amount of cash should be submitted along with the bid.
